In our community there are vulnerable young people who desperately need help... With lives marked by drug and alcohol addiction, poor mental and physical health, family breakdown and often incarceration, their futures can seem bleak.

They are without hope. The good news is, when a young person recognises they need help, they can start to dream of a brighter future.

In 1990, my father, Sir David Martin (former Governor of New South Wales) had a vision to help young people through safety, hope and opportunity. Thirty years on, the success of our programs could not have happened without the foresight of those who planned to leave a gift in their Will to our Foundation.

Sir David Martin Foundation is a Family Foundation, helping young people in crisis.

We help young people in crisis by enabling best practice models of treatment for youth drug and alcohol addiction.

We are the major funder of Mission Australia's Triple Care Farm, a unique youth specific addiction treatment centre for Australians, aged 16-24. Here, young people are given a safe place to get well, prepare for new opportunities, and create a lasting change in their lives.

Since 1990, the Foundation has focused on helping young people in crisis. We have:

- ✓ Raised over \$75 million for youth addiction programs.
- ✓ Funded best practice models of treatment for young people with drug and alcohol addiction.
- ✓ Established the first Youth Withdrawal Centre in NSW.
- ✓ Launched Youth Network, a nationwide expansion of aftercare to keep more young people well, after treatment.
